## EXPLANATORY NOTES

1. This is Extension of authorisation number 0515 of 2017.
2. This Extension of authorisation will be published on the website of the Chemicals Regulation Division of the HSE.
3. Application reference number: COP 2016/00952
4. Persons using the product to which this Extension of authorisation applies should acquaint themselves with and observe all requirements contained in the Regulation (EC) No 1107/2009, including the duty on the holder of any Extension of authorisation to notify information on potentially dangerous effects, a contravention of which is a criminal offence under those Regulations.
5. Neither the efficacy nor the phytotoxicity of the product for which this Extension of authorisation has been granted has been assessed and, as such, the user bears the risk in respect of failures concerning its efficacy and phytotoxicity.

## ADVISORY INFORMATION

**IMPORTANT:** When applying this product under the terms of this Extension of Authorisation, comply with any resistance guidance or restrictions stated on the product label.

Total reliance on one pesticide will hasten the development of resistance. Pesticides of different chemical types or alternative control measures should be included in the planned programme. Alternating with different modes of action is a recognised anti-resistance strategy.

Where flea beetles resistant to products containing pyrethroids occur, this product is unlikely to give satisfactory control. Repeat treatments are likely to result in lower levels of control. For flea beetle control use a suitable insecticide depending on other pests present. Consult a BASIS qualified agronomist.

Growers should consult the IRAG website and the AHDB for further information on the current resistance status and management strategies for all target pests.

This Extension of Authorisation relates to the use of 'Eribea' (M17270) for the control of flea beetle and caterpillar. Applications to be made using three star drift reduction technology in a minimum of 400 litres water per hectare. This requirement applies to crops grown in any protection situation that is not considered to be permanent protection with full enclosure (e.g. poly tunnels).

The product can only be applied using hand held equipment when the crops to be treated are grown under permanent protection with full enclosure. In this situation the aquatic buffer zone does not apply.

## APPENDIX 1: CONDITIONS OF EXTENSION OF AUTHORISATION

The conditions below are obligatory. They must be complied with when the Extension of authorisation occurs. Failure to comply with the following conditions will result in the withdrawal or amendment of the Extension of authorisation under Regulation (EC) No 1107/2009 and may result in other enforcement action, including prosecution. For the purposes of this Extension of authorisation only, the conditions and/or requirements shown below supersede any corresponding conditions and/or requirements set out on the label or otherwise provided for under the product authorisation **which would otherwise apply**.

### Use:

Operator Protection:

- (1) Engineering control of operator exposure must be used where reasonably practicable in addition to the following personal protective equipment:
  - (a) Operators must wear suitable protective clothing (coveralls), suitable protective gloves and face protection (faceshield) when handling the concentrate.

- (b) Operators must wear suitable protective clothing (coveralls) when applying by hand-held equipment.
- (2) However, engineering controls may replace personal protective equipment if a COSHH assessment shows that they provide an equal or higher standard of protection.

Environmental protection:

- (1) Horizontal boom sprayers must be fitted with three star drift reduction technology for all uses.
- (2) Crops/situations with >5m buffer zone:

Since there is a risk to aquatic life from use, direct spray from horizontal boom sprayers must not be allowed to fall within the distance specified for the crop of the top of the bank of any static or flowing waterbody or within 1m of the top of a ditch which is dry at the time of application.

Spray must be aimed away from water.
- (3) To protect non target insects/arthropods respect an unsprayed buffer zone of 5 m to non-crop land
- (4) Buffer zones must be measured in accordance with the guidance set out in the booklet 'Local Environment Risk Assessment for Pesticides - Horizontal Boom Sprayers' available from HSE Chemicals Regulation Division's website and any amendments made to it.
- (5) The results of the LERAP must be recorded in written form and must be available for a period of three years for inspection to any person entitled to exercise enforcement powers under or in connection with the Plant Protection Products Regulations 2011 or the Plant Protection Products (Sustainable Use) Regulations 2012. (An electronic record will satisfy the requirement for a written record, providing it is similarly available for inspection and can be copied).
- (6) Dangerous to bees. To protect bees and pollinating insects do not apply to crop plants when in flower. Do not use where bees are actively foraging. Do not apply when flowering weeds are present.

Other specific restrictions:

- (1) When used on crops/situations with a greater than 5m aquatic buffer zone this product must not be applied via hand-held equipment.
- (2) This product must only be applied in accordance with the terms of this extension of authorisation, the product label and/or leaflet and any additional guidance on extensions of authorisation.
- (3) Buffer zones greater than 5m are NOT eligible for buffer zone reduction under the LERAP scheme.
- (4) Hand held use must only be used on crops grown under permanent protection with full enclosure.
- (5) Low drift spraying equipment must be operated according to the specific conditions stated in the official three star rating for that equipment as published on HSE Chemicals Regulation Division's website. These operating conditions must be maintained until 30m from the top of the bank of any surface water bodies.

## **APPENDIX 2: GENERAL CONDITIONS FOR AN EXTENSION OF AUTHORISATION**

Failure to comply with the following conditions will result in the withdrawal or amendment of the Extension of authorisation under Regulation (EC) No 1107/2009 and may result in other enforcement action, including prosecution.

### **Adverse effects:**

The authorisation holder must immediately notify the Secretary of State, the Scottish Ministers and the Department of Agriculture and Rural Development in Northern Ireland (care of the Health and Safety Executive), if they have any new information on the potentially adverse effects of the authorised product, or of residues of an active substance in that product when used in accordance with the conditions of this Extension of authorisation. For those products authorised under Regulation (EC) No 1107/2009 authorisation holders must also tell the other relevant competent authorities of the EC Member States (a list of which is available from the Health and Safety Executive) and the EC Commission. Failure to comply with this requirement is an offence.

### **Provision of information:**

The authorisation holder must comply with all requests for information required by, or on behalf of, the Secretary of State, the Scottish Ministers or the Department of Agriculture and Rural Development in Northern Ireland in accordance with Regulation (EC) No 1107/2009.
