This Extension of Authorisation relates to the use of 'Gibb 3' (M17013) as a plant growth regulator on outdoor cherry.

Applications are to be made in a minimum water volume of 110 litres per hectare.

The latest time of application for the product is 'at petal fall' (BBCH 69-70)
